

#### **DECLARATION OF POSTAL BALLOT RESULTS**





- In terms of the provisions of Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014, I was appointed as a Scrutinizer of the Company to conduct the Postal Ballot including e-voting for passing of the Resolutions as contained in the Notice of Postal Ballot dated May 30, 2014 (herein after referred to as "Notice").
- 2. I submit my report as under:
  - (a) The Company has completed the dispatch of Notice along with the Postal Ballot Forms and self-addressed stamped envelopes through Registered Post on June 06, 2014 to the members, whose names appeared on the Register of Members/ List of Beneficiaries as on May 23, 2014.
  - (b) Particulars of all the postal ballot forms received from the Shareholders and the votes cast by electronic mode, if any, have been entered in a register separately maintained for the purpose in electronic mode.
  - (c) The Sealed Postal Ballot Forms received from the shareholders were kept under the safe custody of the Company.
  - (d) All Postal Ballot Forms, received up to the close of working hours (17.30 hours) on July 07, 2014, the last date and time fixed by the Company for receipt of the forms were considered for my scrutiny.
  - (e) Envelopes containing Postal Ballot Forms received after 17.30 hours on July 07, 2014 were not considered for my scrutiny. These envelopes were not opened.




